**Minutes of Meeting held on 18.05.2019 under the Chairmanship of Hon'ble Administrator-cum-Observer Shri S.P. Garg, Former Judge, Delhi High Court in Room No. 1, Raisina Bengali School, Mandir Marg, New Delhi-1**

The meeting was attended by the following persons :-

Following issues were discussed:-

The meeting was called of the Office Bearers of the erstwhile Governing Body to request them to make available the records pertaining to Donors/Patrons/Subscribers who have since been admitted as voters. The said record is not available in the GB's room. The election have been delayed due to non availability of

records pertaining to this category. The Ld. Administrator desired to convene meeting of the ex office bearers for this purpose.

Shri Swapan Kumar Ganguly, Ex. President, Shri Ranajit Samaddar, Ex. Vice President and Mr. Ram Chandra Goldar, Ex. Joint Secretary did not attend the meeting. They did not send any intimation. When contacted on phone Mr. Ram Chandra Goldar informed that he was having stomach problem. The other two did not respond.

All the ex-office bearers were asked if they were in custody/possession of the records pertaining to Donors/Patrons/Subscribers. All of them denied and stated that they were not having such record and cannot produce it. It was informed by Mr. Ranjan Kumar that no Patron was admitted as member. He further informed that there was a Donor Members List for 2017-18 consisting of around 734 members in this category and said list was provided to the previous Returning Officer. It was further informed that earlier Shri Ashish Halder was Chairman and all the records were with him and he produced photocopy of the minutes of meeting dt. 4.2.17 in which Shri Ashish Halder was expelled and the minutes of the meeting bears signatures of all except Shri Ashish Halder.



He further informed that the entire photocopy of the minutes of the meeting was regularly handed over to Shri. D. Chakravarty, Principal. Shri D. Chakravarty agreed to have been handed over the photocopy of some of the minutes which were available with him. He further states that rest of the minutes were not handed over to him.

A specific question was asked to the ex-office bearers present if the Voter List of 2017-18 of around 734 Donors etc. was acceptable to them to be taken as basis for holding election for 2019-21. They all said that the said Voter List was acceptable to them and can be taken as basis for holding the present election.

Some concerns were raised regarding the genuineness of the donors of Bijnaur, UP. They were assured that all efforts will be made that only genuine voters participate. It was decided that a meeting be held on 22.5.19 at 2 p.m. with the Lawyers representing the parties to ascertain their views on behalf their clients.

The meeting ended with a vote of thanks to the Chair.
