**“SCRUTINY OF NOMINATIONS AND DISPLAY OF FINAL LIST OF CANDIDATES”**

Intimation Letters, along with Nomination Forms to each voter/ member; were sent requesting them to intimate their willingness to serve in the Governing Body of the Society by Speed Post between 26.08.2022 and 29.08.2022 as per the draft Voter List published on 26.08.2022. Final Voter List after consideration of the objections against the draft Voter List was published on 04.09.2022 and Intimation Letter and Nomination Form were sent by Speed Post on 04.09.2022 to the newly added members in the Final Voter List.

Last Dates for receipt of nomination forms and withdrawal of nomination, which were originally scheduled on 06.09.2022 till 3:00 P.M. and 07.09.2022 till 2:00 P.M., respectively; have been extended to 08.09.2022 till 3:00 P.M. and 09.09.2022 till 2:00 P.M., respectively; in accordance with the Proceeding of Objections to Draft Voter List as approved by the then Ld. Returning Officer-cum-Election Observer and subsequently notified vide Notice no. RBSS/GBE/22-24/04-06, dated 04.09.2022.

09 (NINE) Nominations have been received with supporting documents pertaining to educational qualification and experience in educational field. Scrutiny of these Nominations as well as documents have been carried-out. However, 01 (one) Nomination, namely that of MR. BIMAL KUMAR GHARAMI (Voter Sl. No. 3507 & Nomination Form No. 0179 received vide Receipt No. 06, dated 07.09.2022); has been withdrawn by him vide letter and email dated 09.09.2022 (12.50 P.M.). Same have been kept on record.

It is observed from the scrutiny of the rest of the Nomination Forms that the nomination filed by MR. AJAY MANDAL (Voter Sl. No. 3508 & Nomination Form No. 0050 received vide Receipt No. 07/ dated 07.09.2022) that the name (surname) of the candidate as well as his father's name (surname) in the Nomination Form and educational qualification documents are different, though he has submitted an affidavit dated 17.06.2008 in support of change of his name. The due process for change of name as prescribed in law requires publication in the official gazette – the proof of which has not been submitted by Mr. Ajay Mandal. Hence, in absence of complete supporting legal document/s, his Nomination stands rejected.

07 (SEVEN) remaining Nomination Forms are found to be fulfilling the criteria of educational qualification and experience. Accordingly, list of these Nominees be prepared and published as Final List of Candidates. Further, in consideration of only 07 (SEVEN) nominations being found valid and eligible to be included in the Final List of Candidates and since as per the Fundamental Rules of the Society, Governing Body Election is held for seven candidates; NO voting is required to take place and the processes of issue and receipt of Voting Papers and counting thereof accordingly stand disposed off.
