**"SCRUTINY OF NOMINATIONS AND DISPLAY OF FINAL LIST OF CANDIDATES"**

Intimation Letters, along with Nomination Forms to each voter/ member; were sent requesting them to intimate their willingness to serve in the Governing Body of the Society by Speed Post/ Courier Service between 26.08.2025 and 27.08.2025 as per the draft Voter List published on 23.08.2025. Final Voter List after consideration of the objections against the draft Voter List was published on 29.08.2025 and Intimation Letter and Nomination Form were sent by Speed Post on 29.08.2025 to the newly added members in the Final Voter List.

Last Dates for receipt of nomination forms and withdrawal of nomination, which were originally scheduled on 02.09.2025 till 6:00 P.M and 03.09.2025 till 2:00 P.M., respectively; was extended up to 04.09.2025 till 5:00 P.M. and 05.09.2025 till 1:00 P.M., respectively; considering postal and courier delays as notified vide Corrigenda bearing no. RBSS/2025-26/GBE/25-27/08, dated 27.08.2025 and no. RBSS/2025-26/GBE/25-27/10, dated 03.09.2025.

08 (Eight) Nominations have been received with supporting documents pertaining to educational qualification and experience in educational field. Scrutiny of these Nominations as well as documents have been carried-out. However, 01 (one) Nomination, namely that of MR. BUDDHADEV MUKHERJEE (Voter Sl. No. 3306 & Nomination Form No. 3306 received vide Receipt No. 08, dated 04.09.2025); has been found to be defective for the reason/s of (i) the date of proposer being overwritten and prior to the date of Nomination and (ii) mismatch in Voter Sl. No. of the Secunder and accordingly, the nomination filed by MR. BUDDHADEV MUKHERJEE hereby stands rejected.

07 (SEVEN) remaining Nomination Forms are found to be in order as per rules. Accordingly, list of these Nominees be prepared and published as Final List of Candidates. Further, only 07 (SEVEN) nominations being found valid and eligible to be included in the Final List of Candidates and since as per the Fundamental Rules of the Society, Governing Body Election is held for seven candidates; NO voting is required to take place and the processes of issue and receipt of Voting Papers and counting thereof accordingly stands closed as not necessary.
