CBSE CLASS X RESULTS

The CBSE Class X Board Examinations were scheduled to be conducted from 15.02.2020 till 20.03.2020. However, due to wide spread of Covid-19 pandemic, the exams scheduled from 19th to 31st March had to be postponed. After reassessing the situation and worldwide spread of Covid19, it was decided that Board will no longer be able to conduct examinations including those to be conducted in North-Eastern Delhi.

Looking at the uncertainties and unprecedented situation, the Hon'ble Supreme Court of India passed orders on 26.06.2020, approving the assessment scheme of CBSE for class X to compute results on the following criteria:

ASSESSMENT SCHEME

- a) For the students, who have completed all their examinations, their results will be declared based on their performance in the examinations.
- b) For students who have appeared in the examinations in more than 3 subjects, the average of the marks obtained in best three performing subjects will be awarded in the subjects whose examinations have not been conducted.
- c) For students who have appeared in the examinations in only 3 subjects, the average of the marks obtained in the best two performing subjects will be awarded in the subjects whose examinations have not been conducted.

CONDUCT OF COMPARTMENT EXAMINATION

CBSE will announce the schedule of these examinations subsequently in consultation with the Government of India.

CBSE DECLARES CLASS XII RESULTS TODAY

The CBSE Class XII Board Examinations were scheduled to be conducted from 15.02.2020 till 30.03.2020. Due to spread of Covid-19 pandemic, CBSE was forced to cancel examinations scheduled from 19.03.2020 to 30.03.2020 in 12 subjects along with examinations in 11 subjects for students of North-Eastern Delhi. These exams were re-scheduled to be held from 01 to 15 July 2020.

Looking at the uncertainties and unprecedented situation and keeping in mind the health and well-being of students, the Hon'ble Supreme Court of India passed orders on 26.06.2020, approving the assessment scheme of CBSE to compute results on the following criteria:

ASSESSMENT SCHEME

- a) For the students of both classes X and XII, who have completed all their examinations, their results will be declared based on their performance in the examinations.
- b) For students who have appeared in the examinations in more than 3 subjects, the average of the marks obtained in best three performing subjects will be awarded in the subjects whose examinations have not been conducted.
- c) For students who have appeared in the examinations in only 3 subjects, the average of the marks obtained in the best two performing subjects will be awarded in the subjects whose examinations have not been conducted.
- d) There are very few students of class-XII, mainly from Delhi, who have appeared in the examinations in only 1 or 2 subjects. Their results will be declared based on performance in the appeared subjects and performance in internal/practical/projects assessment. These students will also be allowed to appear in the optional examinations conducted by CBSE to improve their performance, if they desire to do so. Result of these students will also be declared along with other students. **

CHANCE FOR OPTIONAL EXAMINATION

- CBSE will conduct an optional examination in the subjects whose examinations scheduled to be conducted from 01st July to 15th July 2020 as soon as conditions are conducive as assessed and decided by the Central Government.
- Candidates whose results have been declared based on the assessment scheme
 will be allowed to appear in these optional examinations to improve their
 performance, if they wish so. Marks obtained by a candidate in these optional
 examinations will be treated as final for those who had opted to take these
 examinations.



FREQUENTLY ASKED QUESTIONS ON EXAM RESULTS AND COMPARTMENT EXAMS

S.No.	Question	Answer
1.	What does the term RT in the marksheet mean?	The term RT means REPEAT IN THEORY. This is the term used from 2020 instead of FAIL IN THEORY(FT)
2.	What does the term RP in the marksheet mean?	The term RP means REPEAT IN PRACTICAL. This is the term used from 2020 instead of FAIL IN PRACTICAL(FP)
3.	What does the term ER in the marksheet mean?	From 2020, CBSE has replaced the term FAIL with ESSENTIAL REPEAT.
4.	Why are the result of few candidates declared as R. L.	Results of a few candidates have been declared as RL as some data is not available. RL means result later. CBSE, after declaration of result will see these cases separately and needful action to declare the result will be taken.
5.	In the marksheet of Private candidates practical marks are not reflected. Why?	In 2020, in some of the subjects, there has been change in the maximum marks for theory examination as compared to 2019. In all such subjects, marks obtained in theory part has been proportionately increased and increased marks have been added in theory marks and result has been declared. Marks being shown in theory are out of 100.
6.	What does this 'P' represent inside green circle found in result of class 12th declared	It is due to a programing error. The same has now been rectified and it will not be reflected in the marksheet provided by CBSE.
7.	In marksheet result showing in one subject "G", what does it mean?	It is due to a programing error. The same has now been rectified and it will not be reflected in the marksheet provided by CBSE.
8.	Will the marks given in the subjects as per assessment criteria change in case of change in marks after verification and re-evaluation processes?	Any increase of decrease of marks due to verification or re-evaluation will also have an effect on the marks awarded as per assessment criteria.

9.	What do the grades given against marks indicate?	The grades are relative grades. They will vary from subject to subject every year. They are based on the number of candidates passing the subject. Details of these grades are provided at the back of the Mark Sheet provided by CBSE.
10.	When will compartment examination be held?	Compartment examination will be held as soon as the situation is conducive and in consultation with Govt. of India for holding the examination. Notification dated 14.7.2020 may be referred.
11.	When can the form for compartment examination be filled.	Details will be made available as soon as the date is declared.
12.	What is the procedure if any candidate is not satisfied with the marks?	The candidate can apply for the below processes as per Notifications dated 14.7.2020 for Class XII and 16.7.2020 for Class X: 1. Verification of marks 2. Obtain copy of the evaluated answer book; and 3. Re-evaluation
13.	Can the marks be got verified without applying and paying fee?	No. There is no such procedure.

CBSE has declared Class XII result on 13.7.2020. In case of the candidates who were unable to obtain qualifying marks in one subject or have not appeared for the examination in any one subject have been placed in compartment category. As per scheme of examination, CBSE has to hold the compartment examination.

In addition, CBSE will also conduct optional examination for the candidates whose results have been declared based on the assessment scheme, in the subjects whose examinations were scheduled to be conducted from 01st July to 15th July 2020. Candidates will be allowed to appear in these optional examinations to improve their performance, if they wish so. Marks obtained by a candidate in these optional examinations will be treated as final.

Also, students who applied for Improvement of Performance, 2nd chance Compartment and for Additional subject in 2020 and their examinations could not be conducted, shall also be eligible to appear in the examination conducted for above two categories.

The dates of the conduct of examination will be informed soon in consultation with Government of India.
